

Post-Service Employment

Once the PC leaves the uniformed services they may roll on the civilian employment tables below. This is referred to as adventuring. They have been offered a position with one of the many companies or corporations within the Imperium:

Employment Offers From: (3d6)

- 3 Non-Governmental Organization (Private Charity Groups) (i.e., Interstellar Red Cross / Imperial Anti-Cruelty Society / Central Animal Protection Association)
- 4 Government Agency (Bureaucrat) (GM may specify echelon and agency)
- 5 Political Office (Appointed Official / Elected Politician / Political Aid / Lobbyist) (GM may specify echelon and office)
- 6 Private Expedition Service (Field Research / Big Game Hunting / Planetary Exploring)
- 7 Private Collection Agencies (Skip Tracers / Starship Repo Operatives)
- 8 Media Corporation (Broadcast Reporter / Print Journalist / Photographer (Cameraman) / Producer)
- 9 Megacorporation (Executive Management / Executive Security / Freelance Troubleshooter / Private Pilot) (GM may select from the many listed in Traveller)
- 10 Corporate Mercenary (Militia) Company
- 11 Private Starship Company (Corporate Charter / Speculative Trade / Special Courier / Privateering)
- 12 Commercial Transport Line (Transport Fleet / Passenger Cruise Line)
- 13 Bail Bonding Service (Bounty Hunter)
- 14 Mining Consortium (Belter / Prospector / Mining Superintendent)
- 15 Private Detective Agency (Private Investigator / Ghost / Covert Systems Technician)
- 16 Private Security Company (Body Guard / Special Security / Armored Transport)
- 17 Private Consultant / Entrepreneur
- 18 Choice or Other Option

If the employment contract results in a roll of zero no contract exists, the PC is a free agent.

*All employment includes the standard benefits of 500,000 ICrs of term life insurance, full medical & dental insurance, gym membership, credit union membership and a 100% matching

401k retirement plan. At managerial levels and above this includes country club membership, a corporate car and interest free loans from the corporate emergency fund.

Position denotes a meaningful job within the corporation while holding supervisory or managerial authority over a department or office. These titles can range from Special Consultant, Corporate Troubleshooter, Project Manager and Technical Advisor to Associate Vice President to President / CEO. The GM should keep in mind the PCs background and training in offering a position title.

Corporate Expense Account denotes the PC can spend corporate funds in the performance of his or her official duties. This includes travel expenses, rental equipment, clothing, transportation, etc. The limit is 100,000 ICr without higher approval and 1,000,000 ICr with higher approval.

Office with Staff denotes the PC is assigned a suite of offices with a personal assistant or aide along with numerous clerical assistants.

Corporate Stock Option denotes that the PC receives 100,000 ICr per year in corporate stock in lieu of pay.

Performance Bonus denotes the PC performed their duties above expectations bringing in new accounts or income sources. This is 20% of their gross salary.

Partnership Option denotes that the PC is awarded a percentage of the overall corporate profits. This option is only given to senior executives. The PC will receive .1% of the gross corporate profits each year for the rest of their life. Corporate profits will be rolled using 1d6 in billions of ICr. This may allow the PC to finance their own starship or mercenary unit.

Annual Employment Roll (2d6)

PC will roll annually as long as they choose to work/adventure. They must fulfill the terms of their contract or be sued for breach. If the PC is terminated by the employer the game actually begins (no further development rolls).

- 2-5 Employment terminated
 - 2 Fired for suspected criminal activities; blacklisted in that industry
 - 3-5 Fired for cause (no reference)
 - 6-12 Corporate layoff (reference given)
- 6-12 Employment continued for another year

Golden Parachute denotes a severance package if the employment contract is terminated prematurely by the megacorporation. If the PC holds a supervisory position they'll receive 25,000 ICr for each year remaining on the contract. If the PC has a manager position they'll receive 50,000 ICr for each year remaining on the contract. If the PC has an executive position they'll receive 75,000 ICr for each year remaining on the contract.
